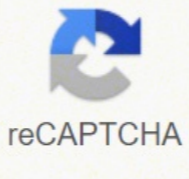

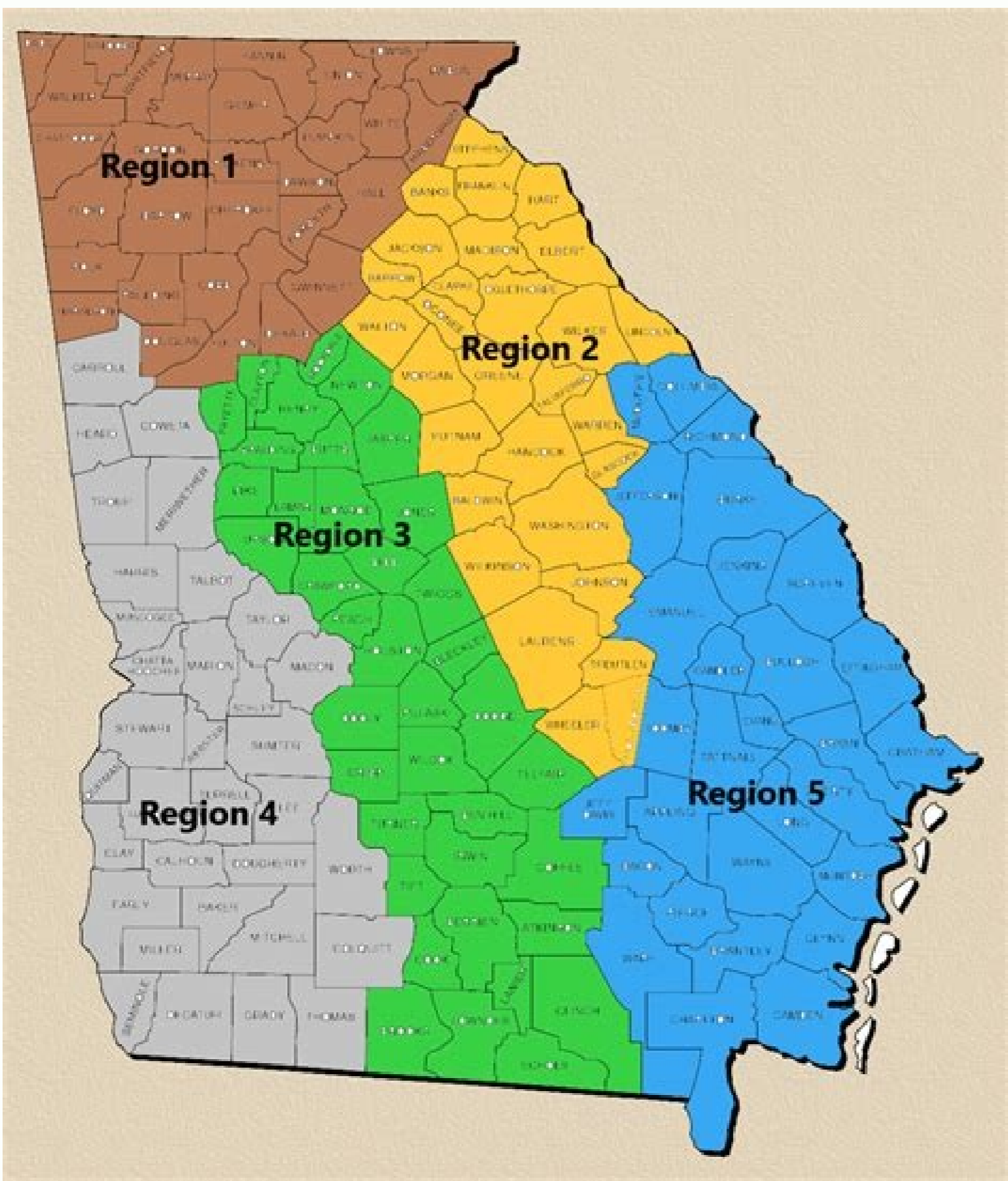

A: The State Patrol of Georgia (GSP), the Capitol Police (CPS) and the Carrier Motor Compliance Division (MCCD) are compliance divisions within the Department of Public Safety of Georgia (DPS). A: Can you pay all available DPS records available through EPORTS? Responding, available reports are recovered, reviewed and written by us, as well as that produced to you during office hours, M-F, 8 A.M. to 4:30 p.m. For example, if you send an EPORTS request a Saturday, you should not wait for the production of documents until at least on the next Tuesday, which would be a 24-hour cycle (M to T) for our receipt and response during the hours of office. EPORTS also allows you to pay for copies of any records requested of and received from DPS. Similar reports prepared by municipal and county police departments, sheriff's offices or other state agencies are not available through EPORTS. For purposes of documenting and clarifying the scope and timing of the request, it is a better practice to make the request in writing. A: CyberSource will send a direct receipt to you by email. A: Yes, EPORTS is available 24 hours a day, 7 days a week, and 365 days a year for requesting citations, crash, and incident reports, excluding the limited downtime for periodic, routine maintenance. CyberSource is administering payments made for DPS reports and materials. A: Crash reports and incident reports are generally prepared and available within three to five business days of the occurrence, although multi-vehicle crashes and those resulting in serious injury or death often require additional completion time. A: Redaction means that all lawfully protected personal and confidential information, including phone numbers, day and month of birth, and medical information, will be redacted or hidden from view.
